### **Decision made and reasons:**

**Decision –** That the decision to award the next contract for the testing and inspection of all Hackney Carriages and Private Hire Vehicles who operate their business within the Borough of Dacorum be delegated to the Assistant Director (Legal, Democratic & Regulatory) or the Group Manager (Legal Governance).

**Reason**: As part of the taxi licence with the Council, drivers have an MOT test and Compliance check carried as part of their fee. The current contract for the testing of Hackney Carriages and Private Hire Vehicles with Ed's Treads is due to expire on the 6<sup>th</sup> June 2012.

The Council must have the new Taxi Testing contract in place by the 7<sup>th</sup> June 2012.

The Council is currently out to tender for the new contract with a closing date of 28<sup>th</sup> May 2012.

By delegating the decision to award the next contract for the Taxi Testing of Hackney Carriages and Private Hire Vehicles to the Assistant Director (Legal, Democratic & Regulatory) or the Group Manager (Legal Governance), the Council will be able to complete the evaluation and award the contract before the 7<sup>th</sup> June 2012.

scores for all bidders, the methodology undertaken during the evaluation process and a recommendation as to who should be awarded the contract.

**Risk**: The risk of not awarding a contract by the 7<sup>th</sup> June 2012 would mean having to extend the current contract. If the current Contractor was unable or unwilling to extend the contract there is a risk the Council would be without a suitable Contractor to carry out the testing of Hackney Carriages and Private Hire Vehicles. Without a Contractor, the Council are putting users of taxi services at risk.

**Options Considered and Reasons for Rejection:** Should the Council not award this contract in the allotted time, it could have a major impact on the Borough's taxi companies and the service they provide.
