



# School and Youth Group Art Recycling Sculpture Competition

## Terms and Conditions of Competition Prize Draw

1. This draw is organised and promoted by Environmental Services Department, Climate Change and Sustainability Department, Community Partnership and Hemel BID. The Forum, Marlowes, Hemel Hempstead, HP1 1DN
2. DBC reserves the right to, where necessary, hold void, cancel, suspend or amend this draw at any time without prior notice. Any changes will be posted on DBC's website located at: [www.dacorum.gov.uk](http://www.dacorum.gov.uk)
3. In the event of any dispute regarding this draw, the decision of DBC shall be binding and final and no correspondence or discussion shall be entered into.
4. Qualifying entrants: entrants must satisfy the following conditions to enter this competition:
  - Must complete the Schools and Youth Group Art Recycling Competition surveys on survey monkey by Friday 6 October 2023.
  - All sculptures must be completed by Friday October 2023.
  - Must be a primary school, secondary school or youth group within Dacorum borough.
  - Must agree to allow the environmental projects team to share photo of all artwork on the Dacorum Borough Council communications channels.
5. Qualifying entrants will automatically be entered into the prize draw, and entry to the draw is free, subject to compliance with term number 4 above.
6. DBC reserves the right to:
  - a) verify that any entrant complies with the conditions in term number 4 above AND
  - b) to disqualify any entrant if it has reasonable doubt to believe any entrant has breached any of these terms and conditions.
7. The competition will close at midnight on Friday 6 October 2023, after which the winning artwork will be selected by The Mayor, and Portfolio Holders for Climate Change and Neighbourhood Operations. The winning school or youth group will be notified via email and their name publicised on the Dacorum webpage, social media platforms and communication channels along with their artwork. Details will be shared about the delivery of the prize once winner has been selected. All artwork will be shared on DBC's communications channels.

8. DBC cannot accept responsibility for any error, omission, interruption, deletion, defect, delay in operation, communications line failure, theft, destruction, alteration of, or unauthorised access to entries, or entries lost or delayed whether or not arising during operation as a result of a technical fault (including but not limited to computer hardware or software failure, satellite, network or server failure, server functions, viruses or bugs) or any other causes outside of its control.

9. DBC cannot accept any responsibility for any damage, loss, injury or disappointment suffered by any entrant school staff and students and except as is permitted by law DBC its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of DBC, its agents or distributors or that of their employees. Qualifying entrants' statutory rights are not affected.

10. The prize includes an exciting half-day papermaking workshop from Frogmore Paper Mill's education team for the primary-aged winning school/group and a workshop run by a local artist for the secondary-aged winning school/group.

11. By entering the competition, all entrants are deemed to accept and abide by these terms and conditions.

If the selected winner does not contact DBC by email within two weeks of being notified by email to confirm their address for the delivery of the prize then the winner's prize will be forfeited and DBC will be entitled to select another winner in accordance with the process described in term 7 above.

### **Data Protection and Publicity**

13. Any personal information provided will be used solely for the purpose of this competition. DBC will not share an entrant's personal details with anyone. Personal information supplied during the course of this promotion may be passed on to third party suppliers only insofar as required for fulfilment/delivery/arrangement of the prize.

14. DBC reserves the right to use the names of the entrant schools and participating staff and students in any publicity. Staff and students will be entitled to remain anonymous if they wish but must state this to DBC upon entering the draw.

15. These terms and conditions shall be governed by English law and all entrants submit to the jurisdiction of the English courts.
