Decision made and reasons:

To undertake formal consultation on the proposals to introduce no waiting at any time restrictions on the northwest side of Wood Lane End from a point approximately 8 metres northeast of the centre line of its junction with Whitmores Wood to the western kerb-line of its junction with the access lane to Kiln Cottage. The proposed Order would discourage parking on this section of Wood Lane End which currently results in traffic congestion.

BACKGROUND

Wood Lane End is one of the roads leading into the Maylands Business Park area.

Much of Wood Lane End is subject to waiting restrictions during the day.

A number of banks provide facilities in an area in which a limited number of parking spaces are available.

The road adjacent to this area is not currently subject to any waiting restrictions.

At times of peak demand for these facilities the requirement for parking spaces outstrips the availability and drivers inappropriately park in Wood Lane End which results in a build-up of traffic as the road is not wide enough to accommodate two-way traffic when cars are parked.

An informal consultation with the local residents and businesses was undertaken in December 2011 and early January 2012 to gauge their support for the proposal to introduce a no waiting at any time restriction in the 45.5 metre section of Wood Lane End adjacent to the banking area between Whitmores Wood and Kiln Cottages. There was a 41% response rate, 87% of respondents supported the proposal and 13% of respondents opposed the proposal.
